#### Plan Type

- RENT CREDIT: 6 months of rent may be applied toward purchase of any instrument in the shop.
- PAYMENT TERMS: the first month's rent is payable in advance and is not refundable. Subsequent rent is due no later than the 5th of each month beginning \_\_\_\_\_
- PAYMENT OPTIONS (check one):  
 Bank Draft—automatic monthly deductions from bank on the 5<sup>th</sup> of each month (\_\_\_\_\_)
   
 Credit Card Draft—automatic monthly charges on credit card on the 5<sup>th</sup> of each month (\_\_\_\_\_) **\$2.00 Service Fee applies**
  
 Monthly Billing—bill me (\_\_\_\_\_) **LATE FEE of \$10 if not postmarked by the 15<sup>th</sup> of each month**
- RETURN POLICY: Instruments may be returned at any time without penalty, provided: (a) customer account is current; and, (b) the items are returned in the same condition as when rented, with the exception of normal wear. The customer assumes full liability in case of accidental damage, fire, theft, vandalism, etc. from the time the rented items are received until they are returned or purchased. The customer also assumes full liability for legal fees incurred in the enforcement of this agreement. **Instruments must be returned by the 30<sup>th</sup> of the month to avoid rental fees for the following month.**
- OWNERSHIP: George Robinson Violins retains full ownership of all items rented until they are paid for in full or returned subject to the provisions in the return policy (No.4)
- LATE PAYMENT: when any payment is more than thirty days past due, the account is delinquent with any remaining balance becoming due and payable. The customer authorizes George Robinson Violins to debit the account designated in the Security Authorization above for payment of any delinquent account or any charge for damage or loss. The customer also assumes full liability for legal fees incurred in the collection of any delinquent account.

- TRADE-IN POLICY: 50% of original purchase price (less maintenance\*) may be applied toward instrument of equal or greater value. The cost of any additional repairs will be deducted from the trade-in allowance.  
 \*Maintenance includes, but is not limited to, strings, bow hair, cleaning and adjustments.
- WARRANTY: George Robinson Violins warrants each instrument and bow (exclusive of strings and bow hair) rented or sold by them to be free from defects in material and workmanship for a period of one year from the first date of rental/purchase. Bow hair is guaranteed for thirty days from the first date of rental/purchase. Strings on rented instruments cannot be guaranteed. We will also perform any necessary minor repairs and adjustments free of charge during the first year following the first date of rental/purchase. This warranty does not include repair of damage caused by accidents, misuse, carelessness, or extremes of temperature and humidity. There are no other warranties either expressed or implied.
